  - i. The health district is currently conducting an internal survey of food operations for service quality provided by staff.
- b. *Housing*
  - i. J. Gruza continues to work on the following previously reported housing nuisances:

    - 3. Yellow Springs-Fairfield Road
- c. *Mosquito Control*
  - i. The health district is continuing to apply larvicide, inspect mosquito breeding sites in areas of known mosquito activity, and trap mosquitoes for testing.
  - ii. As of 09/20/17 Greene County has 20 pools of mosquitoes test positive for West Nile Virus (WNV) in Beavercreek, Bellbrook, Fairborn and Sugarcreek Township. Following are the confirmed mosquito-related cases of disease: one WNV Greene County, 19 WNV State of Ohio, and four Zika Greene County (travel related).
- d. *Nuisance*
  - i. D. Shontz continues to work with the Shawnee Hills Property Owner’s



Association Board regarding nuisance and rodent conditions.
