

# GREENE COUNTY PUBLIC HEALTH HEALTH COMMISSIONER'S REPORT October 26, 2018

#### 1. **Administration**

- a. *Accreditation* (A. Steveley, S. Wynn)
  - i. The Public Health Accreditation Board is scheduled to meet November 20, 2018.
  - ii. Several surveys that inform the Strategic Plan were conducted this month. The surveys were for workforce development, customer satisfaction, strengths and opportunities, and employee satisfaction. Themes from the surveys inform the strategic priorities for the agency.
  - iii. J. Gruza conducted a survey of employee satisfaction with health insurance benefits. Ms. Gruza is completing her master's degree in Public Health with Kent State University. Ms. Howell is her preceptor.
- b. *Administration* (M. Howell)
  - Greene County Health Commissioner Howell is participating on the Ohio Association of Boards of Health committee creating the educational DVD for boards of health in Ohio. Ms. Howell was selected as a presenter this year.
- c. Emergency Preparedness (K. Caudill)
  - i. We have partially activated the emergency response plan due to increased confirmed cases of Hepatitis A and the recent death of a Montgomery County resident. Information and education are being provided to the community, families and healthcare providers. Specific recommendations from the Centers for Disease Control and Prevention are used to identify at risk individuals who can benefit from the Hepatitis A vaccination.
- d. Facility (B. Brooks)
  - i. Demolition of the previous health district is nearly complete.

#### 2. **Communicable Disease** (A. Schmitt)

- a. Greene County has identified seven (7) cases of Hepatitis A infection that is linked to the national outbreak. All seven cases were hospitalized and have a history of intravenous drug use. They are all female and have recovered.

# 3. **Environmental Health** (Jeff Webb)

- a. Body Art
  - i. T. Myers received plans and licensed another microblading facility. Greene County now has 17 body art establishments.



- ii. T. Myers provided comment to the Ohio Environmental Health Association on the newly proposed body art regulations.
- b. Food
  - i. C. Propes and R. Schairbaum are working with a Bellbrook facility to obtain compliance following a Director's meeting.
  - ii. M. Isaacson, S. Jensen and R. Schairbaum are working in conjunction with Ohio Environmental Protection Agency and the Greene Country Club to address water well and wastewater treatment system concerns.
  - iii. Greene County received 10 food-related complaints this month.
- c. Mosquito Control
  - i. Two pools of mosquitoes tested positive for West Nile Virus in October. The mosquitoes were from the area in northern Fairborn between North Broad Street and Sandhill Road. The Special Services team applied larvicide in this area on to help eliminate the adult mosquitoes. The weather during the first half of October had above normal temperatures that allowed mosquitoes to remain active. The last week of October included temperatures below freezing which will greatly decrease mosquito activity. The mosquito program will stop at the end of October. ODH will stop testing mosquitoes on October 31 and will compile the final West Nile Virus results soon after.
